Article 2. General Acceptance of Reports

Shall the reports of school district agents, auditors, committees, or officers chosen be accepted and placed on file?

Article 3. Operating Budget

Shall the Sanborn Regional School District raise and appropriate as an operating budget, not including appropriations by special warrant articles and other appropriations voted separately, the amounts set forth on the budget posted with the warrant, or as amended by vote at the first session, for the purposes set forth therein, totaling Thirty Three Million Four Hundred Fifty Eight Thousand Nine Hundred Thirteen Dollars (\$33,458,913)? Should this article be defeated, the default budget shall be Thirty Three Million One Hundred Ninety Nine Thousand Nine Hundred Eighty Five Dollars (\$33,199,985), which is the same as last year, with certain adjustments required by previous action of the Sanborn Regional School District or by law; or the governing body may hold one special meeting, in accordance with RSA 40:13, X and XVI, to take up the issue of a revised operating budget only. (This warrant article does not include appropriations in any other warrant article.)

Article 4. Fund Balance Retention

Shall the School District vote to authorize, indefinitely until rescinded, the retention of year-end unassigned general funds in an amount not to exceed, in any fiscal year, 2.5% of the current fiscal year's net assessment, for the purpose of having funds on hand to use as a revenue source for emergency expenditures and over-expenditures under RSA 32:11, or to be used as a revenue source to reduce the tax rate, all in accordance with RSA 198:4-b, II?

Article 5: Recorded Votes and Numerical Tally

Article 6: Estimated Tax Impact

The determination of the estimated tax impact shall be subject to approval by the governing body.

Article 7: Rescind Senate Bill (SB2)(RSA 40:14-VII

By petition of 25 or more registered voters, Shall we rescind the provisions of RSA 40:13 (known as SB2), as adopted by the Sanborn Regional School District on March 12, 1996, so that the official ballot will no longer be used for voting on all questions, but only for the election of officers and certain other questions for which the official ballot is required by law? (3/5 majority vote required)

Article 8. Tax Cap

By petition of 25 or more registered voters, To see if the Sanborn Regional School District will adopt the provisions of RSA 32:5-b, and implement a tax cap whereby the governing body of the Sanborn Regional School District shall not submit a recommended budget that increases the amount to be raised by local taxes based on the prior year's actual amount of local taxes raised by more than 10%? (3/5 majority vote required)
